Full Day:

*Mon-Fri 8:00-5:30*

Cost:

- 4 or 5 days- \$175
- 3 days- \$130
- 2 days- \$95
- 1 day - \$50

Half Day:

*Mon-Fri 8:00-12:30 or 1:00-5:30*

Cost:

- 4 or 5 days- \$105
- 3 days- \$80
- 2 days- \$55
- 1 day - \$30

### **Ages**

3-4 year olds may register for any half-day mornings

5-12 year olds may register for any mornings, afternoons, or full day camp

## **Registration/Payments**

Summer Camp may be registered for and paid for in up to four payments according to the payment schedule below. For planning and scheduling purposes, we must receive payments on time for the corresponding weeks signed up for. There will be a \$10 late fee for payments made after the due date. If you would like to attend certain weeks and it is past the payment due date, we will take late entries based on availability. Schedule and payment dues are as follows:

Weeks 1/2/3/4: May 30 <sup>th</sup> - June 23 <sup>th</sup>	Payment due by May 19 <sup>th</sup>
Weeks 5/6/7: June 26 <sup>th</sup> -July 14 <sup>th</sup>	Payment due by June 16 <sup>th</sup>
Weeks 8/9/10: July 17 <sup>th</sup> -Aug 4 <sup>th</sup>	Payment due by July 7 <sup>th</sup>
Weeks 11/12/13: August 7 <sup>th</sup> -August 25 <sup>th</sup>	Payment due by July 28 <sup>th</sup>

\$100 deposit is due at the time of sign up

\*\*There will be no refunds or transfer of payments for no-shows. However, we will accommodate schedule changes within a payment period for a \$10 change fee per occurrence. There will also be an additional \$10 fee for sign-ups the day of attendance.\*\*

## **Sibling Discount**

There will be a 10% discount for the second sibling and a 20% discount for any additional siblings.
